TERMS & CONDITIONS

Information on how to enter to win a Double Pass to Sunset Sessions and a Deluxe Camping Package on Cockatoo Island for completing and submitting the entry form as part of these terms and conditions.

By participating, entrants agree to be bound by these terms and conditions.

ELIGIBILITY

- Entry is open to residents in Sydney, Australia, aged **18 years and over**. Employees and their immediate families of the Promoter and its agencies associated with this Promotion are ineligible to enter.

ENTRY

- The Promotion commences on **Tuesday, 16th December 2025 at 12pm AEDT** and closes on **Monday, 12th January 2026 at 11:59pm AEDT** ("Promotional Period"). No entries will be accepted outside of the Entry Period.
- To enter, all participants must complete;
 - Visit the competition page on the Concrete Playground website.
 - Submit an answer to the 25 words or less (25 WOL) question provided "In 25 words or less, tell us why you need a Sydney staycation".
 - Complete the entry form with all required contact details, including but not limited to name, email address, and any other fields specified.
 - Opt in to receive the Harbour Trust's Cockatoo Island eNewsletter *[Note: Entrants may opt out at any time by clicking the 'unsubscribe' option in the footer of any future Cockatoo Island eNewsletter they receive]*.

- All entries are deemed to be received at the time of receipt by the Promoter, not the time of transmission by the Entrant. Records of the Promoter and its agencies are final and conclusive as to the time of receipt.

PRIZES

- The total prize value is **AUD\$245**. The winner (1) will receive the following:
 - **1 x Double Pass** (2 tickets) to see a 2026 Sunset Sessions show on Cockatoo Island of the winner's choosing (subject to ticket availability) for any given show. Tickets valued at AUD\$38.00. From January 12 onwards.
 - **1 x Deluxe Camping Package**, enabling the winner and a guest to stay overnight, on the same date as the preferred Sunset Sessions show, in the
